

**What's Your Art?
Skateboard Design Contest
Presented By ADK TEEN LLC**

\$20 Nonrefundable Entry Fee required

1. Eligibility: What's Your Art? Skateboard Design Contest (the "Contest") is open only to legal residents of the Adirondack Park who are between the ages of 13-19 years old at the time of entry. Board members of ADK TEEN LLC as well as their immediate and extended family (aunt, uncle, cousin, spouse, parents, siblings and children) and household members of each such member, are not eligible. The Contest is subject to all applicable federal, state, and local laws and regulations and is void and otherwise where prohibited.

2. Sponsor: ADK TEEN LLC.

3. Agreement to Official Rules: Participation in this Contest constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

4. Timing:

- a. The Contest begins on January 1st 2019 at 12:00 a.m. Eastern Time and ends on June 1st 2019, at 11:59:59 p.m. Eastern Time.

5. How to Enter:

- a. All entrants must submit an "Adirondacks" inspired design on the supplied skateboard deck template.
- b. Designs must be submitted in .jpg format. The design should be created in 300 dpi. However, for initial judging and contest entry, please submit your design in a 72 dpi format (5mb max).

- c. If you are selected as the winner, you will be asked to re-submit your entry in 300 dpi for printing.
- d. You must enter electronically via the form on the “What’s Your Art” page.
- e. All information provided by entrants must be complete, true and correct. Entries to the Contest must be received by 11:59:59 pm on June 1st 2019 Eastern Time in order to be eligible; entries received after that date will be deemed ineligible to win.
- f. All submitted entries become the property of the ADK TEEN LLC and will not be returned; ADK TEEN LLC is not responsible for lost, late, inaccurate, incomplete, damaged, illegible, or misdirected entries. Each entry must be submitted on an individual basis, (i.e., no team, joint, or corporate entries) and all components of the entry must be the original creation of the submitting participant.
- g. Only non-commercial work may be submitted. Entries may not contain political references, drug related references/images, profanity, nudity, pornographic images, violent images, anti-competition messages, illegal material, or material that violates the rights of third parties. Entries may not include confidential information, trade secrets, trademarks or copyrighted material belonging to any person or entity other than the entrant absent a suitable license or permission agreement, proof of which is required. Entries containing any forbidden matter or material otherwise deemed by ADK TEEN LLC to be inappropriate will be disqualified.
- h. Online entries will be deemed submitted by the authorized account holder (legal parent or guardian’s email is permitted) of the email address submitted at time of entry. All entries must be submitted through the online submission form on the “What’s Your Art” page and will include a \$20 nonrefundable fee. Individuals may enter multiple submissions. In the event of a dispute as to any entry, the authorized email account holder used to enter will be deemed to be the entrant and must comply with these Official Rules.

6. Winner Determination:

- a. A panel of judges consisting of ADK TEEN LLC board members will select the winning entry based equally upon the criteria of

incorporation of the Adirondacks theme, originality, creativity, and skill. The entry with the highest score will win the Grand Prize. By entering, you agree to be bound by these Official Rules, and that the decisions of the judges are final and binding in all respects. Judging will be completed by June 15th 2019 , and potential winners will be notified by the e-mail or phone number listed on the entry form on or before June 30th, 2019. ADK TEEN LLC reserves the right not to select any winning entries based upon the quantity or content of entry. Potential winners may be required to sign and return a sworn Affidavit of Eligibility and Liability and Publicity Release. If required documentation is not returned within seven (7) business days of notification, or if notification is returned as undeliverable, any prize will be forfeited and an alternate winner will be selected.

7. Prizes:

a. ONE (1) GRAND PRIZE:

- i. A two night trip to Six Flags Great Escape Lodge and Indoor Waterpark for the winner and 3 guests (total of 4 guests to include at least one adult). This includes access to the indoor Lodge Water Park and the outdoor Splashwater Kingdom and theme park at the Great Escape Lodge and Water Park in 89 Six Flags Drive, Queensbury, NY 12804

- b. All expenses not specified above, such as meals, beverages, entertainment, telephones, souvenirs, gratuities, insurance, personal or spa services, etc., are solely each Winner's responsibility. All accommodations and reservations will be arranged by the winner and Great Escape Corporation and are subject to advance notice, holiday blackout dates, and availability. Trip must be taken on dates specified or will be forfeited without further responsibility on the part of the Contest Entities. Other Trip restrictions may apply. All Winners must possess required travel documents. Sponsor has no responsibility for lost, stolen, misplaced, or mutilated tickets and/or travel documents, baggage, flight delays, or any other occurrences beyond its control. Sponsor has no responsibility for a Winner's inability or failure to accept or utilize the prize as described herein. Prize is not

transferable or substitutable except by ADK TEEN LLC with one of equal or greater value. Prizes will be awarded within thirty (30) days after winner verification.

8. Release:

- a. By receipt of any prize, winners agree to release, indemnify and hold harmless the Program Entities and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Contest or receipt or use or misuse of any prize.

9. General Conditions:

- a. ADK TEEN LLC reserves the right to cancel, suspend and/or modify the Contest, or any part of it, at any time, or if any fraud, technical failures or any other factor impairs the integrity or proper functioning of the Contest, as determined by ADK TEEN LLC in its sole discretion. If terminated, ADK TEN LLC may, in its sole discretion, determine the winners from among all non-suspect, entries received up to time of such action using the judging procedure outlined above. ADK TEEN LLC, in its sole discretion, reserves the right to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest; or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner and void all associated entries. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages and other remedies (including attorneys' fees) from any such person to the fullest extent permitted by law. ADK TEEN LLC's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

10. Limitations of Liability:

- a. Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrant, printing, typographical or other errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) printing, typographical, technical, computer, network or human error which may occur in the administration of the Contest, the uploading, the processing or judging of entries or the tabulating of votes, the announcement of the prizes or in any Contest-related materials; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use or misuse of any prize (including any travel/activity related thereto). Released Parties are not responsible for misdirected or undeliverable entries or for any technical problems, malfunctions of computer systems, servers, providers, hardware/software, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmission or any combination thereof. Released Parties are not responsible for any unauthorized third party use of any entry.

11. Privacy:

- a. By entering, you agree that your submitted skateboard template design may be released to a third party for the purpose of printing and advertising.
